October 13, 2020

A Regular Meeting of the Piscataway Township Council was held on October 13, 2020 via the telephone meeting format, Zoom. The meeting was called to order by Council President, Gabrielle Cahill, at 7:30 pm.

Mrs. Cahill made the following Statement, in compliance with the Open Public Meetings Act: Adequate notice of this meeting has been provided as required under Chapter 231, P.L. 1975, specifying the time, date, location and, to the extent known, the agenda by posting a copy of the notice on the Municipal Building, Municipal Court and the two Municipal Library Bulletin Boards, providing a copy to the official newspapers of the Township and by filing a copy in the office of the Township Clerk in accordance with a certification by the Clerk which will be entered in the minutes.

On roll call, there were present: Messrs. Bullard, Cahn, Lombardi, McCullum, Shah, Uhrin, and Cahill. Mrs. Cahill led the salute to the flag.

No comments from Administration and Council on the Adjournment of any Agenda items.

Mrs. Cahill opened the meeting to the Public for comments regarding the Consent Agenda Items. There being no comments this portion of the meeting was closed.

Mayor Wahler read the following proclamation:

Whereas, distracted driving is a growing challenge on our roadways claiming thousands of lives and injuring hundreds of thousands more each year in the United States; and

Whereas, talking on a mobile phone even in hands-free mode, texting, programming your dashboard infotainment system or GPS device can divert your attention away from driving and result in physical or cognitive distraction; and

Whereas, the Township of Piscataway holds paramount the health and safety of its residents; and

Whereas, distracted driving is a serious, life-threatening practice that is preventable and requires the cooperation of all levels of government and the general public; and Whereas, the National Safety Council and Keep Middlesex Moving work to promote policies, practices and procedures leading to increased safety on roads and highways; and Whereas, increased awareness about the dangers of distracted driving may reduce the number of crashes, traffic fatalities and injuries; and

Now therefore be it resolved, that I, Brian C. Wahler, Mayor of the Township of Piscataway, County of Middlesex, State of New Jersey and the Piscataway Township Council fully endorse the month of October as Distracted **Driving Awareness Month** now marking its tenth anniversary and encourage the residents of Piscataway to increase safety for all by pledging to practice safe driving habits.
