July 23, 2024

A Regular Meeting of the Piscataway Township Council was held on July 23, 2024 at the Piscataway Municipal Building, 455 Hoes Lane, Piscataway, New Jersey. The meeting was called to order by Council President Cahill at 7:30 p.m.

Ms. Cahill made the following Statement, in compliance with the Open Public Meetings Act: Adequate notice of this meeting has been provided as required under Chapter 231, P.L. 1975, specifying the time, date, location, login, or dial-in information, and, to the extent known, the agenda by posting a copy of the notice on the Municipal Building, Municipal Court and the two Municipal Library Bulletin Boards, Municipal Website, providing a copy to the official newspapers of the Township and by filing a copy in the office of the Township Clerk in accordance with a certification by the Clerk which will be entered in the minutes.

There will be public comment periods for both remote and in person attendees separately. Each member of the public shall only have one opportunity to speak during each public portion. As the technology does not allow us to know if there are multiple callers on an individual phone line or logged in user account, we ask that if you wish to speak, that you login in or dial in separately so that we can recognize you as a separate individual.

Should you have any further comments or questions, the Township Council is always available by email and phone, and you can always call the Mayor's office during normal operating hours.

WHEREAS, Kashiv Biosciences LLC request that the Township of Piscataway (the "Township") assert Title 39 jurisdiction on the property located at 20 New England Avenue in the Township (the "Property"); and

WHEREAS, the Township has determined that it would serve a public purpose for it to assert Title 39 jurisdiction on the Property; and

WHEREAS, the administration has reviewed the request and recommends enforcement of Title 39 on the Properties; and

BE IT THEREFORE ORDAINED by the Township Council of the Township of Piscataway, County of Middlesex, State of New Jersey, that Chapter VII, Traffic, Section 40, Control for the Movement and the Parking of Traffic on Public and Private Property, of the Revised General Ordinances of the Township of Piscataway are hereby amended with additions shown in italics text as follows:

CHAPTER VII TRAFFIC 7-40 CONTROL FOR THE MOVEMENT AND THE PARKING OF TRAFFIC ON PUBLIC AND PRIVATE PROPERTY.

7-40.3 Regulation for the Movement and the Parking of Traffic on All Other Private Property.

In accordance with the provisions of N.J.S.A. 39:5A-1 the regulations of Subtitle 1, Title 39 of the New Jersey Statutes are hereby made applicable to the properties listed below.

I. 20 New England Avenue.

a. The Township of Piscataway asserts Title 39 jurisdiction over the property located at 20 New England Avenue, Piscataway, NJ and authorizes the Township of Piscataway Police Department to enforce same.

b. The Township Attorney and the Township Administrator are hereby authorized to take all actions necessary to assert Title 39 jurisdiction over

the property, in accordance with the terms of this subsection.

BE IT FURTHER ORDAINED that if any article, section, subsection, sentence, clause or phrase of this Ordinance is, for any reason, held to be unconstitutional or invalid, such decision shall not affect the remaining portions of this Ordinance and they shall remain in full force and effect, and to this end the provisions of this ordinance are hereby declared severable.

BE IT FURTHER ORDAINED that all other ordinances in conflict or inconsistent with this ordinance are hereby repealed, to the extent of such conflict or inconsistency. In the event of any inconsistencies between the provisions of this Ordinance and any prior ordinance of the Township, the provisions hereof shall be determined to govern. AUTHORIZING EXECUTION OF FINANCIAL AGREEMENT WITH RG NORMANDY URBAN RENEWAL LLC PURSUANT TO THE LONG TERM TAX EXEMPTION LAW, N.J.S.A. 40A:20-1 ET SEQ.

WHEREAS, the Local Redevelopment and Housing Law, N.J.S.A. 40A:12A-1 et seq. (the "Redevelopment Law") authorizes municipalities to determine whether certain parcels of land in a municipality constitute areas in need of redevelopment and to adopt redevelopment plans for such areas; and

WHEREAS, by Resolution #22-395 adopted on December 13, 2022, the Township Council ("Township Council") identified and designated the property located at 10 Normandy Drive and identified as Block 3702, Lot 1.02 on the Township's official tax maps (the "10 Normandy Tract" or "Redevelopment Area"), as a non-condemnation area in need of redevelopment pursuant to the Redevelopment Law; and

WHEREAS, by Ordinance #2023-20 adopted on June 27, 2023, the Township Council adopted a redevelopment plan (the "Redevelopment Plan"), which contains certain permitted and conditional uses of the Redevelopment Area, along with development and bulk standards to facilitate a worthwhile and beneficial redevelopment project; and

WHEREAS, Rockefeller Group Development Corporation (the "Redeveloper") is the owner or contract-purchaser of the 10 Normandy Tract and also that certain real property neighboring the Redevelopment Area located at 2 Hancock Road, Piscataway, New Jersey and identified as Block 3702, Lot 2 on the Township's official tax maps (the "2 Hancock Parcel" and, together with the 10 Normandy Tract, the "Project Site"); and

WHEREAS, the Township's Planning Board undertook a preliminary investigation to determine whether the 2 Hancock Parcel is an area in need of redevelopment according to the criteria set forth in N.J.S.A. 40A:12A-5 or is otherwise integral to the redevelopment of the Redevelopment Area; and

WHEREAS, on June 12, 2024, the Township's Planning Board conducted a public hearing, after which it determined to recommend that the 2 Hancock Parcel be designated as a non-condemnation area in need of redevelopment pursuant to the Redevelopment Law, and that an amendment to the Redevelopment Plan be prepared to incorporate the 2 Hancock Parcel as part of the Project Site and overall Redevelopment Area; and

WHEREAS, the Township and Redeveloper are expected to enter into a redevelopment agreement (the "Redevelopment Agreement"), pursuant to which the Redeveloper will demolish the structures existing on the Project Site and construct an approximately two hundred forty-one thousand two hundred (±241,200) square foot warehouse, including ancillary offices, thirty-nine (39) loading docks (13.5' x 60'), sixty (60) trailer parking spaces, one hundred sixty-two (162) parking spaces (9' x 18'), and related on-site and off-site improvements including, but not limited to, stormwater management facilities, utilities, road widening, sidewalk installation, landscaping, and lighting (the "Project"); and

WHEREAS, an affiliate of the Redeveloper, RG Normandy Urban Renewal LLC (the "Entity") has been or will be formed and established as a New Jersey urban renewal entity qualified to do business under the provisions of the Long Term Tax Exemption Law of 1992, N.J.S.A. 40A:20-1 et seq. (the "Long Term Tax Exemption Law"); and

WHEREAS, in order to enhance the economic viability of and opportunity for a successful Project, the Entity submitted to the Mayor of the Township (the "Mayor") an application (the "Application"), which is on file with the Township Clerk, seeking tax exemption in connection with the Project pursuant to the Long Term Tax Exemption Law, in exchange for which the Entity proposes to make payments to the Township in lieu of taxes; and

WHEREAS, the Entity also submitted to the Mayor a form of financial agreement (the "Financial Agreement"), a copy of which is attached as Exhibit 19 to the Application, establishing the rights, responsibilities and obligations of the Entity; and

WHEREAS, the Mayor submitted the Application and Financial Agreement to the Township Council with his recommendation for approval, a copy of which recommendation is on file with the Township Clerk; and

WHEREAS, the Township Council has determined that the Project represents an undertaking permitted by the Long Term Tax Exemption Law.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF PISCATAWAY, NEW JERSEY AS FOLLOWS:

Section 1. The aforementioned recitals are incorporated herein as though fully set forth at length.

Section 2. The Application and Financial Agreement are hereby approved.

Section 3. The Mayor is hereby authorized to execute the Financial Agreement substantially in the form attached as Exhibit 19 to the Application, subject to minor modification or revision, as deemed necessary and appropriate after consultation with counsel.

Section 4. The Clerk of the Township is hereby authorized and directed, upon execution of the Financial Agreement by the Mayor, to attest to the signature of the Mayor and to affix the corporate seal of the Township upon such document.

Section 5. This ordinance shall take effect in accordance with applicable law, and if any part(s) shall be deemed invalid, such part(s) shall be severed and the invalidity thereby shall not impact the remaining provisions of this ordinance.

WHEREAS, the Township of Piscataway (the "Township") is committed to redeveloping the area commonly known as Block 1701, Lot 2.03 (4100 New Brunswick Avenue) (the "<u>Property</u>" or "<u>Redevelopment Area</u>"); and

WHEREAS, the Township adopted a Redevelopment Plan in 2022, however no redevelopment has occurred at the Property and the existing tenant is still in operation and intends to continue operations indefinitely; and

WHEREAS, the adopted Redevelopment Plan does not include the current use that is in operation currently; and

WHEREAS, if the current tenant desired to complete any improvements on the Property, the current Redevelopment Plan would require the tenant to obtain a large amount of variances that would create an undue burden on the tenant and impede improvements to the Property; an

WHEREAS, the Township Council wishes to the keep current M-5 zoning uses and standards intact as the underlying zone to facilitate the current use and facilitate improvements to the Property; and

WHEREAS, the Township Planning Board by Resolution on June 12, 2024 recommended adoption of Addendum to the Redevelopment Plan to the Township Council as prepared by 4Site Planning LLC., entitled "4100 New Brunswick Avenue Redevelopment Plan Addendum, Block 1701, Lot 2.03", dated April 17, 2024, that would maintain the current M-5 zoning; and

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Township Council of the Township of Piscataway, County of Middlesex, State of New Jersey, as follows:

- Section 1. The Township hereby approves the Addendum to the Redevelopment Plan, for the area commonly known as Block 1701, Lot 2.03 (4100 New Brunswick Avenue), prepared by 4Site Planning, LLC dated April 17, 2024 ("Redevelopment Plan Addendum") and attached hereto as Exhibit A pursuant to N.J.S.A. 40A:12A-7 of the Redevelopment Law.
- Section 2. Final adoption of said Redevelopment Plan Addendum by the Township Council shall be considered an amendment of the Township of Piscataway Zoning Map. The Zoning District Map in the Zoning Ordinances of the Township is hereby amended to include the boundaries described in the aforementioned Redevelopment Plan Addendum and the provisions therein.
- Section 3. All of the provisions of said Redevelopment Plan Addendum shall supersede the applicable development regulations of the Township's ordinances, as and where expressly indicated, for the Property. In the event of any inconsistencies between the provisions of said Redevelopment Plan Addendum and any prior ordinance of the Township of Piscataway, the provisions of said Redevelopment Plan Addendum shall govern.
- Section 4. Should any section, paragraph, sentence, or clause of this Ordinance be declared unconstitutional or invalid for any reasons, the remaining portions of this Ordinance shall not be affected thereby and shall remain in full force and effect and, to this end, the provisions of this Ordinance are hereby declared severable.

This Ordinance shall take effect immediately upon second reading, final passage and publication as required by law.
